## <u>PL/2023/01954/PPFL for a Battery Storage Facility(BESS) on Henwood Lane. - UPDATE</u>

Further documents appeared on the planning portal just before Christmas. They were all submitted by the applicant and consisted of various documents endeavouring to counter various objections that had been raised in earlier submissions. One document consisted of a number of appeals which had been allowed for other Bess's attached to substations or accompanying solar farms with the PC have suggested should not have any relevance as the developments are not directly comparable to this one. # PL2024/00037/PPOL an application for up to 50 dwellings involving the demolition of existing agricultural buildings, with all matters reserved except access. | Land North Of Lugtrout Lane Catherine De Barnes Solihull

This site in this application forms part of the larger site SO1 (PolicySO1) in the Solihull Local Plan currently being reviewed but held up awaiting news of changes to the NPPF (National Planning Policy Framework). When that plan is adopted the site will be taken out of Green Belt (GB) but currently it remains in GB and as such needs 'Very Special Circumstances' to be accepted and outweigh the position that the development represents inappropriate development in the GB. The RA organised and held a meeting in the Village Hall on the 30<sup>th</sup> January to discuss the application and next steps and Cllrs Bob and Gail Sleigh were expected to attend. The RA will be submitting a response to the application as will the Parish Council. There has been a number of posts on various social media platforms concerning and objecting to the application and members will be encouraged to respond to the application and given guidance as to how etc. at the meeting on the 30<sup>th</sup>.

We understand that this retrospective application is likely to go before the Planning Committee in March and a meeting will be held sometime in February to discuss how local residents can participate in the hearing. Again once the actual date is known a meeting will be organised to establish how we are going to participate in the hearing. It will be extremely valuable for a good turnout of local residents attends the hearing which will be held in the Council's Civic Suite

#### Airport News

A meeting of the Airport Noise Working Group(ANWG) was held on the 7<sup>th</sup> December. Prior to that meeting we arranged for local community groups/PCs etc to discuss how we would wish to see the current Night Flying Policy reviewed/improved and the results of that meeting were passed to the Airport representatives(AR) attending the ANWG meeting. Unfortunately at this time we can't go into more detail concerning potential changes suffice to say we are endeavouring to reduce both day and night time noise limits and limit aircraft movements during the night time period. The AR's took those suggestions for consideration and we await details of a next meeting. #### **BOOK REVIEW**

THE BLACKHOUSE

A Novel by Peter May

PETER MAY BLACK HOUSE

A book review by John Alderson

Any book that requires a guide to the English pronunciation of Gaelic names has to be a little daunting and as I read this book on my iPad, making it difficult to refer back, I remembered them as best I could.

It was well worth the effort. This is quite a powerful novel which brings Fin, a young detective based in Edinburgh, back to his home village of Crobost on the Isle of Lewis, to help solve a murder.

The story is of Fin's return to the village he had left to go to University, to find it hardly changed and many of his old school friends still living there, the murdered man being well known to him.

As he begins his investigation meeting the people he once knew well, we are shown in flashback details of his early life and also the hard way of life on this wild windswept part of the UK that has barely changed in centuries, with descriptions of the sea, the wind and almost constant rain vividly and beautifully portrayed.

There is a lot of hardship and emotion described in this book as Fin gradually works his way towards a conclusion; examining his own early experiences with his attitudes of today.

This is not always an easy read, but I found it fascinating and enjoyable.
