Battery Storage Facility on Henwood Lane, Catherine de Barnes

Unfortunately we have learned that the Planning Inspector has upheld the appeal and the facility will in due course go ahead .

PL/2024/02987/PPRM Oak Farm Hampton Lane Catherine De Barnes Solihull B92 0JB

By the time you read this, we will know what the result of the planning committee will be . The application was being considered on the 13th August . The Association made a personal representation to the Committee objecting to the positioning and materials used in the 3 storey dwellings bordering the canal towpath. The Association together with the PC and the Canoe Club in discussions with Cala and SMBC managed tp ensure a small area of land, currently used by the canoe club but now owned by Cala Homes remains undeveloped and Cala have agreed that the club can continue to use it aiming to give them the freehold of it following completion of the development. This ensures the clubs activities are secured into the future as far as parking etc., is concerned. A great result for all concerned!!

PL2025/01404/PPFL |Installation and operation of a 49.9 MW ground mounted solar farm and 5MW BESS facility together with all associated works, equipment, necessary infrastructure and biodiversity enhancement areas.

The wording of the title of this application is we feel slightly misleading. The site is actually spread over 3 plots of land- one bordering the canal on land at the end of the Common in Bickenhill Lane, a second behind dwellings in Bickenhill Village and the third on land north of the Woodhouse Farm. See the planning portal for full details of the application.

The date for the submission of responses was 26th August but responses received after that date would be generally be accepted so long as the application remains to be considered. We met with representatives of Bickenhill PC and their planning consultant on the 11th August to discuss possible implications of the development on the surrounding area. Any worthwhile information resulting from that meeting will have been notified to members prior to receiving this edition.

Heath Farm 26 Henwood Lane

A number of residents have been in touch concerning the various work being undertaken, As you may be aware there have been a number of applications concerning proposed development of the various buildings on the site. Enquiries have been made to try to establish what the current position is and understand it is as follows:

- 1) The first relates to the re-build of the outbuildings (PL/2025/00113/VAR, for External alterations to previously approved Class Q prior approval consent PL/2023/01507/PNCUDW, was refused in late April). Since this time, the applicant has submitted a fresh application for a new dwelling, but this is currently invalid. As soon as it is valid, there would be the usual assessment, and residents could pass formal comment.
- 2) The second issue relates to the significant works to the original dwelling. As you will recall, this does in fact have a number of approvals (prior notifications) for various large additions. However, since these approvals, the applicant then submitted application PL/2025/00164/PPFL for Replacement existing extended bungalow with a detached two storey dwelling. It is understood that there have been subsequent works to those made originally and a site visit is expected.
- 3) PL/2025/00164/PPFL case (ie the replacement/re-build of the original house). Again a visit is being made on the near future to view the site to assess the building works.

Motorway Service Area (MSA):

Following a recent meeting with the developers it now looks like work will not start until end 2026 early 2027.

Airport News

We are a member of the Airport Noise Sub Group, which met on the 7th August. The group has been formed to monitor and review the current noise policy and discuss potential improvements that might be included in the next policy which is up for review in 3 years. One of the items that has been discussed is the number of noise violations resulting in the reduction of the night time noise limit and what can be done to ensure limits are not exceeded. This means the Airport Company is talking to the airlines who are breaching the limits in what they can do in their procedures to improve things. The group meets again in November.

Village Hall

The hall will revert to a Church again for Remembrance Sunday on the 9th November .

A Christmas tree effect product has been purchased and will be delivered in September which should create an improved lighting effect during the Christmas season.

PL2025/02987/PPRM. Oak Farm up to 85 dwellings (continued)

This application went before the planning committee on 13th August. Local resident Duncan McArdle, representing himself and the Association, gave a slide presentation objecting to the siting of the 3 storey homes on the canalside and suggesting the committee defer any decision until a redesign incorporating buildings with a lower height at this location. This was followed by the legal representative of the owner of Oak Cottage who asserted that, because of an issue re the boundary, that as things stood, the site could not be delivered for housing and a legal challenge to any approval might well follow. A representative from Cala Homes spoke supporting the scheme and then the Chair sought comments from the Committee. Cllr David Pinwell disapproved of the location of the 3 story dwellings as well as having some concerns over the fact that Cala had not fully adopted "Secured by Design" recommendations with regard to lighting.

After some discussion with planning officers the Chair followed their recommendation in asking the committee to approve the application apart from the block of 3 storey homes which they did unanimously. We now have to establish what happens next concerning the redesigning of the homes bordering the canal
