2025/01404/PPFL. Solar Farm Catherine de Barnes and Bickenhill (3 plots of land)

Following discussions with SMBC the applicant has now accepted that an environmental Impact Assessment is required, because of the proximity to the SSSI at Bickenhill Meadows. This assessment is likely to take 2 months and when received the application response clock will be restarted. There is no urgency to send in a response at this point and we will update members when the Assessment has been done and the situation regarding response deadlines. We are in discussions with the Parish Councils of Hampton and Bickenhill concerning this proposal.

PL/2025/01616/MINFHO 53 Hampton Lane

This is a resubmission of application PL/2024/02475/MINFHO.

A two-storey extension to the front and rear of the property.

Airport news

The airport is performing well, and current indications are that it should not reach its ambitious night time movements in the current year. The Noise Group, at which we are represented are due to meet later in the year further discussing potential conditions for the next Night Flying Policy. Just to remind members that the group has been successful in negotiating reduced night time noise levels for the current 3-year period and believe day time noise levels will be reduced in the not-too-distant future. Residents north of the airport are not for one reason or another adequately represented on the Airport Consultative Committee (ACC) and a membership Working Group is being formed to review the membership and make recommendations to the ACC. We have expressed an interest to join this group to ensure our interests are maintained. The ACC met recently and received an interesting presentation on drones which we hope to send to members shortly but one interesting item was that in Darlington, Amazon Air are awaiting approval for starting drone deliveries of items up to 5lb and aim to deliver them within an hour of receipt of the orders. The mind boggles what our skies will look like in a year or so. Currently there is very little regulation on the use of drones for commercial purposes- so the race is on – how will breach of privacy be maintained with these things flying everywhere not just delivering parcels but probably gathering info for all sorts of purposes.

Grand (Union) Designs

How Solihull Canoe Club paddled through planning battles to protect its parking

This is the story of how Solihull Canoe Club, based in Catherine-de-Barnes, and the Parish Council faced – and overcame – a serious threat to its parking area during the planning process for the Oak Farm housing development.

Over two years ago, Cala Homes submitted an outline plan to build up to 98 dwellings on land at Oak Farm, right next to the club's base by the Grand Union Canal. The canoe club responded to Solihull Council, raising safety concerns and requesting an extension to its small but vital parking area. Cala's Land Director met with us early on and confirmed the parking would remain – though he would not commit to any enlargement.

And so began 18 months of back-and-forth: Cala submitted revised applications, the club responded, and meetings were held – but without any firm commitment. Then, in May this year, just before the final Reserved Matters application, everything changed. Cala informed the Parish Council that the canoe club would lose its parking area entirely, as it was to be redesignated as public open space.

Fortunately, Dave Cuthbert and the Parish Council acted swiftly, securing a meeting with Cala. When Cala insisted that the loss of parking was to meet Solihull's Planning requirements, the Parish Council went directly to senior planners and ward councillors to challenge the claim.

Meanwhile, the Canoe Club committee mobilised. Members were encouraged to lodge formal objections, helped along by a "Planning Objection for Dummies" guide and even Al-generated template responses. Over 70 members – including two GB international paddlers – submitted objections, many also contacting councillors and MPs. Our local MP, Saqib Bhatti, gave outstanding support: meeting the club, lodging an objection, pressing Cala directly, and even joining us on the water. We also had the huge benefit of advice from a former club member with decades of housing development experience.

This combined effort paid off. In August, Solihull Council approved Cala's application — but with the canoe club's parking safeguarded. Also, a very determined resident and the Parish Council successfully challenged Cala's proposed three-storey houses along the canal, which will now be re-reviewed as lower-rise buildings. Further legal objections remain under consideration from the residents at Oak Cottage.

The outcome shows that, although our village faces intense development pressure, determined action with strong community backing can make a difference. As Chair of Solihull Canoe Club, I'd like to thank: the club committee, parish councillor's Dave Cuthbert, Giles Cook, John Eccleston, and all our members & residents who stood up to protect the club's future.




Welcome pack for new residents
